REPORT OF THE KAPITI COAST AIRPORT NOISE COMMUNITY LIAISON GROUP FOR THE YEAR ENDING 31 DECEMBER 2014

This the seventh Annual Report of the Community Liaison Group (CLG), which was established to comply with the requirements in the Kapiti Coast Airport Holdings Limited (KCAHL) Noise Management Plan (NMP).

The committee is assisted with advisors from Kapiti Coast District Council.

The purpose of CLG is "to consider and, where appropriate, make recommendations to the Airport Manager on aircraft noise issues and concerns that arise from the operation and activities at the Airport".

This report will describe how aircraft movement numbers have declined at the airport over the last several years and that noise complaints have significantly reduced over time. It is also believed that the nearby residents have a much improved understanding of the airport operations and have become more accepting of noise generated by airport activities. The cessation of the helicopter training operations has certainly been a factor in there being fewer noise complaints but on the other hand the loss of the helicopter activity has been at some economic cost to the Airport and community.

Aircraft Movements Data

The table below shows actual aircraft movements as recorded by the Airport. The airport noise contour modelling for the District Plan was based on 96,000 aircraft movements per annum.

Movements in 2014 decreased versus 2013. This is primarily a result of lower fixed wing training activity by both Helipro and Kapiti Aero Club due to changes in government funding for student pilots and the transfer of Helipro flight training activities to Palmerston North from 31 August 2013.



Total Number of Noise Complaints

The graph below shows the total number of noise complaints received from January 2009 to December 2014 grouped by month, divided into total complaints and the number of first time complainants¹ per month. The moving average shows various spikes in the number of complaints; however the trend for the total number of complaints is continuing to decrease.

¹ The separation of total complaints verses first time complaints serves as an indicator of public awareness of aircraft noise. This is common practice at other airports.

Conclusion

This year has again seen few noise complaints. Those that have come have been handled well.
